Notes

As of March 13, 2013, the Debtors had outstanding debt in the aggregate principal amount of approximately \$1.453 billion, consisting primarily of approximately (a) \$192 million under their senior secured 2012 Credit Agreement, (b) \$896 million under their senior secured Term Loan Facility, and (c) \$366 million under their 12% Second Lien Notes due 2018. The Debtors also had, as of March 13, 2013, accrued and unpaid interest and fees on these principal balances of approximately (a) \$2.4 million under their senior secured 2012 Credit Agreement, (b) \$25.5 million under their senior secured Term Loan Facility, and (c) \$21.5 million under their 12% Second Lien Notes due 2018. Total outstanding debt inclusive of the accrued and unpaid interest and fees as of March 13, 2013 was \$1.503 billion.
